This is the CONTEMPORARY CHOREOGRAPHIC WORKSHOP led by Ivan Cignetti, a freelance teacher, professional dancer, and choreographer. He has worked extensively in theater and television in modern-contemporary and hip-hop dance. Ivan Cignetti is known for his eclectic contemporary style, which blends various techniques and movement languages to create a unique choreographic experience. In his workshops, participants often work on movement sequences that explore contrasting dynamics, fluidity, and structured improvisation, with the goal of discovering the body's potential in relation to space and other dancers. Ivan Cignetti's choreographic work is especially beneficial for students aged 12 to 15, as this is a critical stage in their development. At this age, young dancers begin to develop a deeper awareness of their bodies, technique, and artistic expression.

Rules & Regulations

1. **Eligibility:** Applicants must have at least 2 years of modern/contemporary dance training. Age: 12-15 years.
2. **Number of Participants:** The workshop has a limited number of participants and will be activated with a minimum of 10.
3. **Registration:** To register, download the paper registration form **Choreographic Workshop Registration – Ivan Cignetti** from the website www.interdanza.it, fill it out, and send it to the email address: info@interdanza.it.
4. **Payments and Fees:**
 - Payments must be made via bank transfer:
 - Payee: ARTS4ALL ASSOCIAZIONE CULTURALE

 - The one-time registration fee of 10 euros is mandatory for all participants and is not subject to reductions or exemptions
 - **Choreographic Workshop Fee:** 200 euros (190 euros + 10 euros registration fee).
 - Alternatively: 295 euros (285 euros + 10 registration fee) **for both workshops**, to be paid by January 15;
 - Otherwise, in **two installments**:
 - First installment: 120 euros, or 160 (for both workshops) by January 15.
 - Second installment: 80 euros, or 135 (for both workshops) by March 15.
 - The fee includes the entire workshop series, which will take place from February to May, and participation in the final performance on May 4 at Teatro Goldoni, as part of the International Gala "On the Wings of Dance."
5. **Required Documents:**
 - Completed and signed registration form.
 - Proof of payment (bank transfer).
 - Note: Participants without all required documents will not be admitted. **Registration deadline: January 15, 2025!**

6. **Workshop Locations:** The workshop will take place at two locations in Livorno:
 - Via di Popogna 50, at A.S.D Laboratorio di Danza e Movimento.
 - Via dei Cavalieri 69, at Scuola di Danza Dea.
 - Participants will receive detailed information regarding location and time for each weekend of the workshop.
7. **Opportunities:** Participants will have the option, at a 50% discount, to participate in:
 - A second choreographic workshop (classical with Francesco Testoni),
 - A 30% discount for the final dance stages on May 2 and 3, by completing the registration form.
 - The 10-euro registration fee will not need to be paid again.
8. **Costumes:** Costumes will be the responsibility of the participant.
9. **Refund Policy:**
 - Fees will not be refunded in the case of withdrawal or non-participation, nor will they be transferable or cumulative with other people.
 - Refunds will only be possible in the case of event cancellation by the organization.
10. **Travel and Accommodation Expenses:** Travel, food, and accommodation expenses are the responsibility of the participant.
11. **Minors:** For minor participants, parental or legal guardian authorization is required.
12. **Changes and Cancellations:**
 - The organization reserves the right to make changes to the project in the case of insufficient participation or logistical issues to ensure the proper execution of the activities. Any changes will be promptly communicated.
 - Interdanza reserves the right to cancel the project in case of natural disasters, offering a voucher valid for the following year.
13. **Liability:**
 - The ARTS4ALL association declines all responsibility in case of theft or damage to people or property during the project at the hosting facilities.
 - The ARTS4ALL association is exempt from civil and criminal liability related to participation in the project, including the participants' physical fitness or any injuries.
